Dear Madam/Sirs,

This is with reference to our earlier disclosures dated (i) September 29, 2022, by which the Company had disclosed that Invesco Developing Markets Fund (Invesco) and OFI Global China Fund LLC (OFI) (shareholders of the Company) had filed a petition (Company Petition No. 322 (MB) of 2021) against the Company, before the National Company Law Tribunal, Mumbai Bench (Ld. NCLT) under Sections 98(1) and 100 of the Companies Act, 2013, asking the Ld. NCLT to order an extraordinary general meeting (EGM) of the Company pursuant to a requisition letter issued by them (Requisition), and (ii) March 24, 2022, wherein the Company had updated you that it has received a letter from Invesco and OFI on March 24, 2022 (Letter), stating that they have decided not to pursue the Requisition and accordingly, they will proceed to withdraw the petition. Accordingly, Invesco and OFI filed an interlocutory application (IA No. 57 of 2022 in CP No. 322 (MB) of 2021) seeking that the petition may be disposed of as withdrawn.

On June 7, 2022, the petition along with the interlocutory application for withdrawal, was heard by Ld. NCLT. The Ld. NCLT ordered in open court that the petition shall stand disposed of as withdrawn and all pending interlocutory applications in the petition shall stand closed. The said order was, however, not made available. For this reason, Invesco and OFI filed another application, IA No. 150 of 2022 in CP No. 322 (MB) of 2021, seeking urgent listing and fresh hearing of the withdrawal application. The petition and the urgent listing application were listed before the Ld. NCLT on November 15, 2022. On the same day, the order of the Ld. NCLT passed on June 7, 2022, disposing of the petition, was made available to the Company.

In light of the above, at the hearing on November 15, 2022, the Ld. NCLT noted that in view of the order passed on June 7, 2022, the petition and all interlocutory applications therein have been disposed of, and there is no need for a fresh hearing or order. The final disposal order dated November 15, 2022 was made available on November 22, 2022.



Therefore, the petition filed against the Company is no longer pending before the Ld. NCLT. Orders issued by the Ld. NCLT is enclosed as **Annexures A and B**.

Brief details of the development concerning the above as required under SEBI Circular No. CIR/CFD/CMD/4/2015 dated September 9, 2015, are enclosed in **Annexure C.**


